

2025 Piedad and Raul Castro Scholarship Application

The EBLRLA Scholarship Fund invites eligible candidates to apply for the **Piedad and Raul Castro Scholarship**, an annual \$5,000 scholarship funded by the **Honorable Arturo Castro**, Judge with the Superior Court of Alameda County, in honor of his parents.

“This scholarship is dedicated to my parents, who, alongside countless other immigrant families, personify the perseverance, sacrifice, and selflessness of those who are dedicated to advancing future generations, with no thought or expectation of personal gain. By giving back in their names, the spirit of their sacrifices will live on, supporting young minds who are equally dedicated to making the world a better place.” – Judge Arturo Castro

The **Piedad and Raul Castro Scholarship** will be awarded to an outstanding law student to assist them with expenses related to preparing for the California Bar Exam and transitioning to formal practice as an attorney. Judge Castro will not be involved in the selection process.

Eligibility Criteria:

1. Graduation from law school by spring 2025;
2. Registered for the July 2025 California Bar Exam;
3. Significant ties to, or expects to practice in, the East Bay (Alameda and/or Contra Costa Counties);
4. Demonstrated financial need; preference will be given to students who do not already have all of their bar exam study expenses covered by another funding source;
5. Demonstrated commitment to employing the law to advance social justice; and
6. Demonstrated academic success and potential to succeed as a future lawyer.

The EBLRLA Scholarship Fund aims to support as many deserving law students as possible. While all eligible applicants are encouraged to apply, priority will be given to applicants who have not already received a scholarship from the EBLRLA Scholarship Fund.

We are interested in your background, financial need, hardships or barriers overcome, past efforts to advance social justice, particularly during law school, and future plans as a lawyer.
- **Law School Transcript.** Unofficial copies are acceptable. Enrollment and grade point average are subject to verification.
- **Financial Aid Printout.** Obtain a financial aid printout from your law school student account or financial aid office. The printout should include the calculation of your need, as well as the loans and grants already received.
- **Other Proof of Financial Need.** Include any other supporting documentation to verify your financial need, including other loan debt (e.g., undergraduate, graduate, private loans, etc.).
- **Optional:** Should you feel it necessary, you may also attach a supplemental 300-word maximum statement about your financial need and how this scholarship would assist you.
